\*\*\*Please note; Dogs can only be entered on one course, either Maiden/Novice or Improver/Open

**Program:** Friday – Course 1 – Improver followed by Open. Course 2 – Maiden

Saturday – Course 1 – Novice. Course 2 – Open

Sunday – Course 2 – Championship/ Open Final

Bitches cannot compete if they are in season. Balloting will occur if more entries are received than the time allows.

**Judges** – Improver/Open & Championship – John Latty. Maiden/Novice – Adam James

**Camping** – Powered sites - \$20. Unpowered sites - \$10 to be paid on the entry

**Gate pass** – Associate membership - \$66 (two 3 day passes + parking)

- Single entry - \$24 (1 day pass)
- Parking - \$10/day
